This development was conveyed in a memo dated August 30, 2021 and signed by the Deputy Registrar (Academic Support Services, Senate), Mr. A. Abdulsalam and addressed to the Dean, Postgraduate School, University of Ilorin.

# **PG Board frowns at** delayed papers' submission

he Board of the Postgraduate School, University of Ilorin, has expressed displeasure with the delay in submission of papers for consideration at its meeting, saying that the practice from several departments is hindering efficient service delivery.

The Secretary to the Board, Mr. Mansur Alfanla, stated this in a memo addressed to all Heads of Departments across various Faculties of the University sequel to the resolutions of the Board at its meeting held on April 21,2021.

Mr. Alfanla warned that any Department which failed to meet the deadline for submission of papers would not have such processed for the slated meeting.

#### Ph.D. students must score 50% in oral examination to graduate - PG Board

• o be eligible for graduation, every Ph. D. student must score at least 18 out of 36 points or 50% at the end of his Ph. D. oral examination.

This development was part of the resolutions of the 276th meeting of the Senate of the University held on Thursday, April 18, 2019.

In a memo dated April 24, 2019 which was signed by the then Deputy Registrar, Academic Support Services, Mr. Mansur Adeleke Alfanla, and addressed to the Dean, Postgraduate School, the University Senate insisted that the condition has become an important qualification which every Ph. D. candidate must possess before being awarded the highest academic degree.

#### **Pass your communication** through Deans, PG School tells Heads of Departments

he Postgraduate School, University of Ilorin, has directed Heads of various academic departments to ensure that issues relating to postgraduate programmes addressed to it are routed through their Deans.

The Secretary to the Postgraduate School, Mr. Mansur Adeleke Alfanla, stated this in a memo addressed to all Heads of Departments sequel to the resolutions of the Board of Postgraduate School at its 301st meeting held on Wednesday, December 15, 2021.

The Board described the practice of relating with the Postgraduate School directly by Departments without the awareness of their respective Deans as a breach of the line of communication, which would no longer be entertained.

#### No evidence of payment of school fees, no exams, **PG School warns students**

ollowing the increasing disregard for prompt payment of school fees, the Board of Postgraduate School, University of Ilorin, has warned that students who fail to present evidence of payment of such fees would no longer be allowed to sit for examinations.

The Board, in a memo signed by the Secretary to the Postgraduate School, Mr. Mansur Adeleke Alfanla, and addressed to all Heads of Departments directed that no student should be scheduled for defense unless evidence of payment of the fees is presented. This, according to the memo, applies to examinations for all postgraduate programmes

#### **Curb delay in completion** of postgraduate studies,VC directs

Any academic staff who has less than 3 years to retire from the services of the University of Ilorin would no longer be allocated Postgraduate students for supervision or be part of panel of examiners.

The Vice-Chancellor of the University, Prof. Sulyman Age Abdulkareem, gave this approval on September 30, 2019 while reacting to the delay experienced by some postgraduate students of the University. He, however, said that in case such

supervisees could not complete their work they should be handed over to the Head of the Department for appropriate reassignment to other supervisor(s) as the case may be.

The Vice-Chancellor also approved that a moratorium of 1 academic session be extended to all students that overstayed the approved duration of studies and that whoever fails to finish after the moratorium granted should have his programme terminated forthwith

he Senate of the University of Ilorin has streamlined the procedures for the suspension of studies by students of the University including those on postgraduate programmes.

At the meeting of the Senate held on Wednesday, August 18, 2021, it was reiterated that students could be allowed to suspend their studies for either a semester or session and that such application must be made before the commencement of the semester or session for which approval is sought.

The application must also be from the University portal and it should be processed through the Faculty Board as it was also stated that no student can suspend study for more than a session at a time.

It also directed that the submission of pre-assesement forms for the Ph.D. oral examinations to the Postgraduate School should not be later than 2 weeks before the date of examination.
