1. PREAMBLE

WHEREAS the University of Ilorin (hereinafter referred to as "the University") was established to:

- a. encourage the advancement of learning and to hold out to all persons, without distinction of race, creed, sex, religion, or political conviction, the opportunity of acquiring a higher and liberal education;
- b. provide courses of instruction and other facilities for the pursuit of learning in all its branches, and to make those facilities available on proper terms to such persons as are equipped to benefit from them;
- c. encourage and promote scholarship and conduct research in all fields of learning and human endeavour;
- d. relate its activities to the socio-cultural and economic needs of the people of Nigeria; and
- e. undertake any other activities appropriate for a University of the highest standard.

These objectives would be attainable only in an atmosphere of peace and harmony where the Rule of Law prevails and all students obey and observe all the University's rules and regulations and display a deep sense of honesty, dedication, dynamism, discipline and respect for constituted authority.

The Senate of the University, in exercise of the powers conferred on it by Section 6(4) of the University of Ilorin Act, CAP 455 Laws of the Federation of Nigeria, 2004, and all other powers enabling it in that capacity, hereby makes the following Rules and Regulations:

2. STUDENTS' CONDUCT AND DISCIPLINE

The University is established primarily for the development of students intellectually, socially and culturally. It also aims at inculcating good character as an integral part of education. An acceptance of admission offer by a student into the University, automatically implies that he or she has accepted to abide by the Rules and Regulations that may from time to time be made for governance of the University. Such acceptance also carries with it an obligation that the student shall conduct himself or herself as a law-abiding and responsible member of the academic community in accordance with the University's best standards, rules and other conditions established by the legally constituted authorities of the University.

3. PERSONAL AND ACADEMIC INTEGRITY

- a) It is hereby generally recognized that dishonesty of any kind is a behavioural issue which must be jettisoned. Therefore, beyond any punitive measures as may be prescribed by this regulations and/or other relevant provisions of the University's Act and other Laws of the Federal Republic of Nigeria against any act of dishonesty of any kind, the following are the minimum standards of personal and academic integrity to be strictly and consistently observed by all students:
- i. Be honest and conduct himself/herself in an ethical manner in the pursuit of his/her studies.
- ii. Attend all his/her lectures punctually and be properly dressed in accordance with the acceptable dress code in the University.

iii. Maintain high degree of orderliness and decorum in the class.

- iv. Honestly complete and submit his/her assignments as at when due.
- v. Cite references honestly on assignments.
- vi. Respect ethical standards of the Library in carrying out assignments/research
- vii. Cooperate, if called upon, in the investigation of any allegation of dishonesty pertaining to another student.
- viii. Take pride in upholding the ethical standards of this University through his/her words, writing, attitude and behaviour.
- ix. Regard other members of the community as part of a family and as such live harmoniously and maintain a respectful relationship with them in the classrooms, hostels, offices, etc.
- x. Conduct himself / herself in such a way that his / her priority is to live a wholesome life devoid of anti-social activities, especially cultism. Membership of a cult does not help a student, rather it could lead to his/her sudden death from fellow cult members, or termination of his/her studies through suspension or expulsion. A good, positive and forward-looking behaviour at all times, coupled with good company, should be his/her priority. Avoid anybody who makes overture to him/her to join any unregistered group/association by Student Affairs Office.
- xi. Maintain good personal hygiene. Hostel rooms should be as clean as possible as poor environmental sanitation can lead to outbreak of dysentery, cholera, typhoid, tuberculosis, etc.
- xii. Every student (male or female) must dress decently, as the mode of dressing is a reflection of individual character and personality. Every student (male or female) must avoid any dress that may expose sensitive and vital areas of their bodies. No student shall be involved in pornography either within or outside the

University. Violation of the Dress Code as prescribe	ed by the	e	
University or involvement in pornography is a s	serious	act	of
misconduct which shall attract stiff penalty.			

- xiii. **Be wary of promiscuous living.** The ravaging spread of HIV/AIDS all over the world is a warning to all students. AIDS certainly kills and students should do everything possible to avoid any action that will make him/her a victim of this scourge or spread the disease to others.
- b. Every student of the University is required to maintain a high standard of integrity. *The University regards as serious offences any act of unethical, immoral, dishonest, disloyal or destructive behaviour as well as acts which violate University regulations.* It is the responsibility of each student not only to acquaint himself/herself with these Rules and Regulations, but also to uphold them at all times within or outside the University since the University degree is awarded to students found worthy both in character and learning.

4. DISCIPLINARY RULES

The rules of discipline require that a student shall:

- a. not engage in any form of activity, alone or with any other person or group, which interferes with, restricts, hinders, or adversely affects the objectives of the University which are set out in the Act of the University; or affects the activities of others in or outside the University.
- b. not engage in any form of activity whether alone or with any other person or group which interferes with, restricts, hinders or adversely affects the rights of any person duly authorized and lawfully present on University premises to express any view of any subject peacefully or which prevents any person duly authorized from entering, passing through, or leaving the University premises for such purposes;

j. not impersonate any officer or employee of the University;

- k. not engage in any dishonest, false or other misleading representation or activity which affects academic assessments or examinations and to obey all examination regulations, and
- 1. Not do any other thing or act in any other manner that may negatively affect the University, members of the University Community or any other person(s).

5. SANCTIONS FOR VIOLATION OF REGULATIONS

The following are some of the sanctions which may he imposed for violation of University regulations or Code of Conduct:

a. **Fines**

The Dean of Student Affairs (DSA) and Hall Masters/Mistresses may impose implementable fines (see Appendix A) for certain categories of offences committed in the Halls of Residence. Offences committed in other locations of the University which attract fines will be dealt with by the appropriate authority. Failure to pay the fine within 7 clear days after the imposition of such fine shall lead to such student appearing before the Student Disciplinary Committee (SDC).

b. Restitution

Restitution means that a student must pay for damage done to, loss or misappropriation of the University property or the property of other members of the University community. Such restitution is imposed on any student who alone, or through group concerted activities, organizes or participates in the events which cause damage or loss.

c. Reprimand and Warning

A student may be reprimanded or and warned for violation of University rule and regulations. If he/she were to commit further breaches of discipline in future his/her present offence would be taken into consideration in the course of future hearings when a penalty for that subsequent breach is under consideration.

d. Suspension/Rustication

Any student suspended/rusticated must withdraw from the University for the stated period, and shall further comply with any other condition(s) or requirement (s) related to the suspension/rustication.

e. Expulsion

Any student expelled ceases to be a member of the University and **loses** all rights and privileges of membership. It may also require the payment of compensation in some cases.

f. All cases of expulsion and suspension/rustication will be duly and promptly communicated to all organs of the University, the student concerned and his/her parents/guardians. The name(s) of the student(s) will also be published in national dailies, the University Bulletin and the University website or any other means the University may deem fit. Other Universities in Nigeria will also be notified.

6. INVITATION TO APPEAR BEFORE STUDENT DISCIPLINARY COMMITTEE (SDC) Any student suspected to have committed any act of misconduct shall be charged with such misconduct, and shall

be given 48 hours within which to respond in writing, and be subsequently requested to appear before the Student Disciplinary Committee except in cases of emergency.

7. FAILURE TO APPEAR BEFORE STUDENT DISCIPLINARY COMMITTEE (SDC) Any student invited to the Student Disciplinary Committee (SDC) for any act of misconduct and fails to honour such invitation three consecutive times, shall be deemed to be guilty of the offence so charged.

8. COMMUNICATION OF MANAGEMENT DECISIONS ON DISCIPLINARY ACTION

All decisions of disciplinary action involving students shall be communicated to the affected student(s) through the Head of Department of respective Department(s) and/or pasting same in conspicuous and designated area(s) within the Campus.

9. APPEAL

(i) In all disciplinary cases, the student concerned has a right to appeal to the Council through his/her Head of Department, the Dean of his/her Faculty and the Vice-Chancellor against the decision of the Student Disciplinary Committee or any other person within 48 days of the receipt of the disciplinary decision.

(ii) Appeals shall be considered by Council through an independent Committee of Council which shall make appropriate recommendation to the Council.

10. GUIDELINES FOR ACCEPTABLE BEHAVIOUR

- a. Any student who displays any form of disrespect bordering on contempt to any official of the University, while the latter is performing his/her official assignment, shall be disciplined for Act of misconduct.
- b. Writing of an insulting letter to an official of the University shall constitute an act of misconduct.
- c. No student or group of students shall by-pass the official line of communication while writing to the University Administration. The approved line of communication is through the appropriate Head of Department and the Dean of Faculty. All student grievances (other than academic matters) should be routed through the Dean of Student Affairs to the appropriate arm of the University. Also, correspondence from the Students' Union to the University Administration must be duly signed by both the President and the Secretary of the Students' Union.
- d. Students are not allowed to make communication with outside agencies, governments or national/international organizations for the purpose of soliciting financial sponsorship/aid that may jeopardize the interest of the University.
- e. Unlawful possession of all types of dangerous weapons or firearms e.g. guns, cutlasses, knives, grenades, acids etc. are strictly prohibited.

11. HALLS OF RESIDENCE

a. Accommodation

- i. Due to limited number of bedspaces, accommodation will only be provided to eligible students in the order of preference approved by the University from time to time. The accommodation fees are as approved by the University and advertised from time to time.
- ii. Modalities/procedures for accommodation and application shall be determined by the Dean of Student Affairs from time to time.
- iii. No student shall be accommodated on campus except he/she
- is in good standing and duly registered for the session.
- iv. Expelled student(s) shall automatically be ejected from the Hostel without a right of refund.
- v. Violators shall face disciplinary action.

b. Beddings, Cleaning and Laundry

Students are required to bring along their own beddings (i.e. bedsheets, pillow-cases and blankets) for their personal use. Students in residence will be responsible for the cleaning of their rooms and for their laundry.

c. Exeat

- i. No student may be away from the Hall of Residence overnight without an exeat obtained from the Hall Masters/Mistresses.
- ii. In extreme emergency, a student must leave with the Porters, a written statement indicating destination, reasons for his or her departure and the probable duration of his/her absence.
- iii. **Penalty** a student found to be absent without obtaining the exeat will be ejected from the hostel immediately.

d. Visit to Hall of Residence

- i. A visitor to Hall of Residence shall be received by his/her host/hostess in the Students' Common Room.
- ii. Any student that contravenes/violates this rule shall be ejected from the Hall of Residence immediately, while the visitor, if he/she is a bonafide student of the University shall be penalized for act of misconduct.

e. Approved Hall Functions and Private Parties:

- i. The Hall authorities are responsible for the use to which the grounds, common rooms, **rooms** and notice boards in their halls of residence may be put. Permission to use these facilities must be obtained, in writing, from the Hall Masters/Mistresses, giving at least 48 hours' notice.
- ii. **Meetings**: A written permission issued by the Hall Masters/Mistresses in response to written application must be obtained by any group wishing to hold a Meeting/Function in the Common Room of the Hall concerned.
- iii. **Parties**: A written approval issued by the Hall Masters/Mistresses in response to an application in writing must be obtained by any individual or group wishing to hold a party in the Common Room of the Hall concerned.
- iv. No parties of any description can be held in any room in the hall. All **approved** parties are to be held in the Common Room.
- Approved gatherings involving dancing and drinking must not go beyond 8.00p.m. Under no circumstance should alcoholic drinks or drugs and other related substances be served, consumed, abused or sold anywhere on the Campus.
- vi. Any form of merchandising is prohibited in the hostel.
- vii. Functions held in defiance of (iv v) above shall earn all offenders punishment which can be as severe as rustication or outright expulsion.
- viii. At all other times, the level of musical sound shall be maintained, such as will not constitute disturbance to other students. Failure to comply with this will result in ejection of the offending student(s) from the hostel.

f. Electrical Appliances, Fire and Fire Prevention

- i. The use of certain electrical appliances may cause electrical faults and result in fire hazard. Therefore, *under no condition must electrical appliances like boiling rings, heating coils, hot plates, and multiple outlets etc. be used in students' rooms.* Such appliances can only be used in the laundry/kitchenette.
- Students are allowed to use hurricane lamps but not candles in the student rooms when there is electric power outage. Violation of this rule shall lead to ejection from the hostel. When there is no
 electricity supply, great care and diligence must be taken to avoid

any possible fire outbreak.

iii.	Prohibition of smoking in public places (Student Centre,
	Common Rooms inclusive) is 'a law of this country, and should
	also be obeyed by all students. In line with this, students are not
	allowed to smoke inside their rooms and any other premises
	within the University.

iv. Penalty

Any student found contravening the above regulations and or engaging in activities resulting in fire damage shall be ejected from the Hall of Residence promptly, pending investigation and further disciplinary action.

g. Room and Hostel Cleanliness

Students must make their beds and leave their rooms clean and tidy at all times. They must be prepared to participate in room and hostel sanitation exercise from time to time as the need arises.

h. Cooking in Halls of Residence

Under no circumstances must any student cook in the room. Any student found cooking will be suspended from the Hall of Residence in addition to other disciplinary actions.

i. Fighting

- i. Fighting is prohibited in the University and students who engage in fighting shall be expelled.
- ii. A student that provokes another student or person(s) without retaliation from the other student or person(s) shall be made to appear before the Student Disciplinary Committee and sanction shall range from warning to expulsion.
- j. Pets

For health and sanitary reasons, pet animals, birds, fish and or reptiles are prohibited in and around University Halls of Residence.

k. Unauthorized Residence (Squatting)

- i. Any student found in a room not allocated to him/her shall be ejected from the Hall of Residence. Any such offender shall further face disciplinary action for dishonesty and cheating.
- ii. Any student who aids and abets squatter(s) shall equally be ejected from the hostels and further disciplined for dishonest practice.

iii.	Any student found squatting shall pay the equivalent amount
	required to secure a bedspace.

I. Security of Personal Property

Students are strongly advised to keep large sums of money with the Commercial banks. Doors should always be locked and the keys removed on leaving the room. Students must not leave personal property in their rooms during long vacations. The University will not accept responsibility for loss of properties so left in the Hall of Residence.

m. Parking

Motor cars, motorcycles and bicycles shall be parked in the **appropriate places** provided, at owners' risk.

12. CATERING SERVICES

Students' catering services are provided on the Campus by private caterers. Some are Canteens while others are **Eateries**. Students are to pay for **what they consume** in the Canteens or the **Eateries**.

Catering Rules and Regulations

- a. All students are required to comply strictly with the regulation guiding the canteens and **Eateries** as may be formulated from time to lime.
- b. Any student who exhibits an anti-social behaviour in and around the canteens and **Eateries** in particular and within the campus shall be **arraigned before** the **Student Disciplinary Committee (SDC)** in addition to any further disciplinary action that may be necessary.

13. ORIENTATION OF FRESH STUDENTS

a. Orientation Activities

The orientation of new students to the University usually takes place during the week of resumption for the session. The Student Affairs Unit, in co-operation with other departments/units, organizes the orientation programme. The programme is intended to enable new students to settle down and adjust to University academic, social and cultural environments. Orientation also affords students an opportunity to familiarize themselves with the rules, regulations and procedures of the University. Since ignorance is **not an excuse in law**, the **orientation** activities offer the students a singular opportunity to avoid unnecessary embarrassment.

As part of the Orientation week activities, newly admitted students are able to meet the Registrar, Dean of Student Affairs, Deans of Faculties, Heads of Departments and Senior Administrative Officers. They are introduced to various facilities in the University such as the Library, the Medical services, Counselling services, Sports, Campus transportation, etc.

b. Penalty for Not Attending Orientation Activities

Newly admitted students **are** to attend **ALL** the orientation activities and sign the attendance register. Any student who has **been offered** provisional admission before the Orientation Week, but fails to attend any of the orientation week activities **for no good reason** may have his/her admission withdrawn.

14. **REGISTRATION OF STUDENTS**

Newly admitted students are required to commence registration processes according to the guidelines as may be determined by the University Administration.

15. MATRICULATION, MATRICULATION NUMBERS AND IDENTITY CARD

a. Matriculation

Only students who have satisfied the minimum educational requirements of the University of Ilorin are offered final admission and then matriculated as students of the University. On the Matriculation day, each fresh student swears to the Matriculation Oath which shall be provided by the University (SEE APPENDIX B). Violation of the matriculation oath is a very serious offence which **shall** lead to **disciplinary action**.

b. Use of Matriculation Number

Each student is assigned a Matriculation Number upon registration. No official student paper or document is regarded as complete or valid unless it carries the correct matriculation number.

c. Identity cards

(i) Each matriculated student of the University is issued an official student Identity Card, valid for the period indicated on the card and which should be renewed appropriately. The Identity Card must be worn on the neck on Campus always. Students may be required, at any time, to identify themselves upon request by authorized University officials, acting in the performance of their duties. Some University facilities are open only to students who are able

> to show valid identity cards. Students are required, therefore, to always wear their identity card on their neck at all times. For instance, no student will be admitted to the Library, Lecture rooms, examination venues, Laboratories, Hall of Residence etc. without the Identity card. The cost of each identity card is determined by the University from time to time.

(ii) Loss of Identity Card:

- 1. A student who loses his/her Identity Card must report the loss to **the Deputy Registrar** (Academic **Support Services**) through his/her **Dean/Head of Department/ Faculty Officer** as soon as possible.
- 2. An application for the issuance of a new identity card must be endorsed by the Security Unit of the University and accompanied by a Police Report and Affidavit on loss of identity card.
- 3. New **identity cards** will be issued on payment of a sum which will be determined by the University from time to time.
- (iii) Submission of Identity Card: Student leaving the University upon completion or before completion of his/her programme must return the Identity Card to Deputy Registrar (ASS) through his/her Faculty Officer or any other authorized person(s) as the case may be.
- *(iv) Misuse of Identity Card*: It is an offence for students to misuse their own Identity Card or other students' Identity Card either by

way of transfer or impersonating. Such misuse of Identity Card shall constitute misconduct liable to disciplinary action.

d. Instruction on Presentation of Names

Students are required to present their names (maximum of three names including surname) in the following approved style: surname first in capitals, then other names e.g. AFUYE, Moses Olarinde.

16. UNIVERSITY HEALTH SERVICES

The University has a well-equipped Health Centre. Students must register in the Health Centre as part of the normal registration exercise and, in any case, not later than two months **after matriculation**.

a. Available Services

i. Medical Examination is performed on all fresh students at the point of entry and commences immediately after Students' Matriculation ceremony. The tests include Stool, Urine and Vision tests. Where serious ailment is identified, such student shall be referred to undergo specialized tests.

ii. The Laboratory Section is equipped to carry out basic tests such as (Stool/Urine) - microscopic analysis, Blood - for Malaria parasites; Widal test - for diagnosis of Enteric fever (Typhoid fever) etc.

- iii. Curative Services are provided for students at an appropriate period The unit functions as a Primary Health Care Centre.
- iv. Emergency Services to students are provided 24hours.
- v. Students are referred to other Health Institutions such as UITH when required.
- vi. Environmental Health Services are provided within the University Community e.g. Hostel Inspection, pest control and Health Education for food handlers.

b. Important Notice to Students:

The Student Medical Examination and Registration is Mandatory and is required for students who may request for:

- i, Make Up Examination or tests
- ii. Treatment at the University Health Services Unit.

iii. Clearance before NYSC Service year.

Sanctions

- a. Any student who fails to register at the University Health Centre within two months after matriculation may have to pay specified fines or have his/her admission withdrawn.
- b. Impersonation in the clinic or elsewhere by using other students' clinic identity cards is a very serious offence which shall lead to the expulsion of the student involved.
- c. No medical report/certificate from outside the University Health Services shall be countenanced until it is duly certified by the Director of Health services.

17. UNIVERSITY LIBRARY AND DISCIPLINE

a. Office Hours

The University of Ilorin operates in the following locations: Main Library, Law Library and e-Library within the main campus and College of Health Sciences Library. The Library is open to students upon proper registration with the Library. The opening hours are:

The Library is closed on Public Holidays. The University Librarian shall reserve the right to extend the operation hours during examination period as may be deemed fit. Currently the Library is open 24 hours around examination periods.

b. Discipline

- i. A fine of **Two hundred Naira (№200.00)** is charged for each day a book is kept overdue for the first 15 days and **Five hundred Naira (№500.00)** per day thereafter.
- ii. A fine of **Five hundred Naira (N500.00)** is charged for failure to return a book recalled by the library from the third day of the recall notice.
- iii. Students who persistently fail to return library books or settle library fines shall:
 - a. be reported in writing to their Head of Departments and Deans;

b.	have their names published on the Library Departmental and
	Faculty Notice Boards;

- c. be refused registration in subsequent semesters or years (if they are non-graduating);
- d. have their certificates withheld (if they are graduating students);
- e. be caused to pay three times the current price of the book(s) and Six thousand Naira (N6,000.00) administrative charges.
- iv. Loss or damage to books shall be reported to the Library promptly. The borrower shall be required to pay for replacement.
- v. All cases of stealing, mutilation or defacement of Library books shall be regarded as serious acts of misconduct and shall be referred to the Students' Disciplinary Committee for appropriate disciplinary measures.
- vi. The Library reserves the right to suspend or withdraw all library privileges from person(s) who contravene library regulations. Such cases shall be reported to the appropriate University Authority for further disciplinary action.

18. INTRA-CAMPUS TRANSPORT SERVICE

The University operates an intra-campus transport service. The subsidized fare is fixed by the University from time to time. In addition, other private transportation services are also available. Commercial motorcycle (Okada) is not allowed in the campus. Tricycle operators who register with the University are allowed to operate within the campus.

Attendant Penalties

Any student who is found on a bus without a valid ticket will be deemed to have refused to pay and shall be made to face disciplinary action.

Any anti-social behaviour or misconduct including, but not limited to using abusive language, conducting religious preaching, trading, political campaign or engaging in physical combat with

	Accordingly, students are warned in their own interest to ensure
	that lecture notes, text books, jotters, bags, mobile phones, and
	other related prohibited items are not brought into the
	examination venue. Students are advised to keep their mobile

phones completely away from the venue of the examination, as the University would not take responsibility for loss of mobile phones.

- iv. Students must sign the attendance register at the beginning of each paper.
- v. Having signed the attendance register, no student shall leave the examination hall without submitting his/her answer script.
- vi. No student shall leave the examination hall for whatever reason without informing the invigilator.
- vii. To ensure orderliness in the examination hall, seats shall be arranged according to the number of groups taking examinations at each particular time and students shall not enter the hall until they have been checked of their identity cards and other relevant documents. Students shall keep strictly to the sitting arrangements to avoid confusion. Chairs arranged in the halls used for examination purposes should not, under any circumstances, be removed. Students wishing to do some revision before the commencement of an examination shall do so outside the examination hall.
- viii. While the examination is in progress, communication of any kind between/among **students** is strictly prohibited and any **student** found to be giving or receiving irregular assistance commits an act of misconduct **which shall attract appropriate sanction**.
- ix. Silence shall be observed in the examination hall. The only permissible way of attracting attention of the invigilator is by show of hand.
- x. The use of scrap paper, writing or jotting on question paper is prohibited. All rough work shall be done in the Answer booklet and crossed neatly through. Supplementary answer sheets, which shall not be supplied until **at least** half-an-hour after the commencement of the examination shall be **attached to** the main answer booklet even if they contain only rough work.
- xi. **Students** taking Mathematics or Engineering Drawing and similar courses shall bring their own Mathematical or drawing instruments, which may include compass and dividers, protractors, diagonal scales and set squares. Personal copies of Mathematical Tables **may** be allowed in the examination **provided there are no inscriptions on them**.

- xii. Before handing in their scripts at the end of the examination, students shall satisfy themselves that they have inserted, at the appropriate places, their matriculation numbers and the numbers of the questions answered. Except for the question paper and any other materials they may have legitimately brought with them (as indicated in rules B(iii) and (xi) above), students shall not be allowed to remove or mutilate any paper or material supplied by the University.
- xiii. **Students** shall use their matriculation numbers for examinations. (Students who are in doubt of their correct matriculation numbers are advised to confirm from the Senate and Examinations Office).
- xiv. Students shall not be allowed to submit their answer scripts in the first thirty minutes and last fifteen minutes of any examination.
- xv. Students shall remain seated while invigilators organize the collection of answer scripts.
- xvi. **Students** shall write their names, matriculation numbers, department and sign against them on the attendance sheet.
- xvii. Students intending to use calculators in any University examination should observe the following regulations:
 - a. **Students** shall be permitted the use of electronic calculators **only as specified by their respective Departments**;
 - b. The Calculator must be small (hand-held) battery/solar operated, and mobile phone is not allowed;
 - c. A **student** shall not borrow another **student's** calculator during the examination as this practice shall be construed as giving or receiving irregular assistance during the examination;
 - d. Instruction manuals, **including calculator packets and containers** are prohibited **in the examination hall** as these often contain useful mathematical formulae and methods;
 - e. On entry into the examination venue, the calculator shall be switched off and its memory be made blank;
 - f. Only one calculator per student is allowed;
 - g. **Students** shall make available for inspection by invigilators, their calculators on entry into the examination hall and at any time during the examination, and

the examination venue when his/her conduct is judged to be disturbing or likely to disturb the examination.

- ii. Procedure for investigating alleged Examination Misconduct
- a. Any **student** suspected of any examination irregularity shall be required to sign and submit to Chief Invigilator, a written statement in the Examination hall. Failure to make a written statement shall be **deemed to be** an admission of the charge against such a candidate.
- b. The Chief Invigilator shall report any such action taken to the Dean through the Faculty Examination Coordinator **(Sub-Dean)** immediately after the completion of the examination by other students.
- c. The Dean shall, within 48 hours of receiving a report, set up a panel of not less than three academic staff to investigate the alleged examination misconduct. The report of such investigation shall be made available to the Registrar within four weeks, and he shall on the basis of the recommendation(s), determine whether or not the matter should be processed to the Students' Disciplinary Committee.
- d. The Students' Disciplinary Committee shall, within **six** weeks of receiving such a report, investigate and recommend the penalty in cases of proven misconduct to the Vice-Chancellor in accordance with Section 17 of the University Act.

iii. Penalties

- a. Any student found guilty of the offences contained under Section 16 (B) (xiii) - a-h and Section (C) (a)-(j) shall be regarded to have committed misconduct which shall attract severe punishments ranging from rustication to expulsion.
- b. In a situation where an individual, not registered for a particular course writes an examination on behalf of a student, he/she shall be handed over to the Law Enforcement Agents, if he/she is from outside the University, while the student so helped shall be expelled from the University.

Where the individual is a student, he/she and the student so helped shall be expelled from the University.

c. In a situation where a student sits for an examination in a course not registered for, no score shall be recorded for such a student.

(D) Examination Leakage

Where the Dean has reason to believe that the nature of any question or the content of any question paper may have become known before the date and time of the examination to any person(s) other than the examiners and any official of the University authorized to handle the examination question paper, he may order the suspension of the examination or cancellation of the question paper or the setting of a new paper. He shall then investigate the leakage and report the matter to the Vice-Chancellor.

(E) Absence from Examination

- a. Students shall present themselves at such University Examinations for which they have registered under these Regulations. Students who fail to do so for reasons other than proven ill-health, accident or any **proven** emergencies shall be deemed to have failed the particular examination. Misreading/**ignorance** of the time-table and such other excuses shall not be accepted as a satisfactory explanation for absence.
- b. A student who falls ill during examination period should report in writing to the Dean of his/her Faculty through his/her Head of Department.

(F) Make-Up Examinations

A "Make-Up" Examination is an examination specially arranged for a student or a group of students who could not sit for the normal examinations due to ill-health or any other unavoidable circumstances. Each case shall, however, be treated on its merit.

i. A student who is absent from an examination on account of illhealth confirmed by medical evidence from the Director of University Health Services, may be given a make-up examination in the course(s) missed, **based on approved guidelines by Senate.** Otherwise, he/she shall **take** the **regular examination on**

the following occasion as his/her make-up.

- ii. Approval for make-up examination shall be by Faculty Board **provided** that:
 - a. the ill-health has been reported to the Dean through the Head of Department and
 - b. the **student** has obtained a written, report from the Director of Health Services or his/her designated officer which either:
 - i. is dated prior to the end of the examination, or
 - ii. provides evidence that the student was hospitalized during the period of examination.
 - iii. Application for make-up examinations shall normally be made immediately at the end of the Semester examinations.
 - iv. make-up examinations shall normally be concluded within the first five (5) weeks of the semester following the application for make-up.
- (G) Determination of Result
- i. General

A student shall be deemed to have passed a first-degree examination if he/she has satisfied Senate in all the requirements for the examinations (including all GNS & GSE courses). A student who had been referred in any of these requirements shall be deemed to have passed that examination when he/she has fulfilled the requirements.

ii. Pass Mark

The pass mark shall be 45% in all Faculties, except the MB;BS. and B.NSc. Programmes of College of Health Sciences, DVM Programme in the Faculty of Veterinary Medicine, B.Pharm. Programme in the Faculty of Pharmaceutical Sciences and Doctor of Optometry (OD) programme in the Faculty of Life Sciences where it shall be 50%.

iii. Make-up Examination

Following the conclusion of such examinations (**normally** within the first five (5) weeks of the new semester) the updated good-standing result of such candidate shall be processed through the Deputy Registrar (Academic Support Services) to Senate for approval.

iv. Procedure for Result Verification

- (a) The student completes online "Result Verification Form" available on the University website.
- (b) The student submits the form to his/her Head of Department for onward transmission to the Deputy Registrar (Academic Support Services).
- (c) The HOD, within one week, shall issue to the student, the verified result either confirming the old score or reflecting the new one. A copy shall also be forwarded to the Deputy Registrar (Academic Support Services).
- (d) Where a review occurs, the HOD is under obligation to give reasons and forward a copy of the Verification Report through the Dean to the Director of Academic Planning Unit and Deputy Registrar (Academic Support Services).
- (e) In case the student is still not satisfied with the result, he/she shall obtain a Re-mark Request Form from the Deputy Registrar (Academic Support Services). The Form shall be filled and submitted to the same office.

20. STUDENTS' CLUBS AND ORGANIZATIONS

a. Recognition of Clubs and Organizations:

Students' Clubs and Organizations will only be recognized after the prospective Clubs/Societies must have satisfied the following conditions:

- i. Submission of duly prescribed completed Application Forms to Dean, Student Affairs.
- ii. Submission of letters of undertaking from a staff Adviser/Patron.

iii.	Submission of the Clubs' objectives and constitution,
	which must be in agreement with the objectives and
	constitution of the University.

- iv. Every Club/Organization must renew its registration yearly at the beginning of each session with the Student Affairs Office.
- v. Any Society/organization that publicizes defamatory and malicious material(s) on individual(s) or Institution(s) will be banned and the member(s) involved disciplined.
- vi. All Writers' Clubs and names of their magazines/journals, writers or columnists, must be registered in the Student Affairs Office and approval received before publications commence. Approval for a change of name of any registered organization must also be obtained from the Student Affairs Office before the commencement of operations under new names.

Penalty for violation of this regulation is proscription of that organization and the offender(s) will be made to face disciplinary action.

- vii. Any group of student(s) or individual(s) who interfere with the course of dispensation of discipline on students through frivolous writing or other actions will be liable to obstructing the University authority from performing its authorized duty, and such students(s) would be suspended from the University, in addition to other disciplinary measures that might be taken against such student(s).
- viii. All duly registered Clubs and Associations in the University are normally expected to be affiliated to the Students' Union of the University.

Activities Involving Guests from Outside the University: In keeping with the University's traditional commitment to freedom of enquiry and the pursuit of truth, students' organizations are allowed to organize activities featuring guest speakers of their choice from within and outside the University. However, the University has an obligation to ensure that activities on the campus are conducted in appropriate manner with requisite

b.

protocol. Whenever a **President**, Governor, Minister, Commissioner, Head of Diplomatic Mission or other dignitaries from outside the University are to be invited, the Dean of Student Affairs must be informed in writing at least **four** weeks before the guest is expected to arrive on the campus.

The University authorities will then decide on the application since it reserves the right to approve or disapprove such an application.

21. GUIDELINES AND REGULATIONS FOR CAMPUS, MEDIA ORGANIZATIONS AND STUDENT CAMPUS JOURNALISM

- a. No Media organization shall operate as Campus Media Organization until and unless it is duly registered with the Student Affairs Office.
- b. Any student who wishes to practise as a freelance campus Journalist shall register his or her real names, aliases, pen names as well as his or her credentials with the Student Affairs Office.
- c. It shall be unlawful for any student of the University to practice as a freelance campus journalist within the University campus without first registering his or her name with the Student Affairs Office.
- d. It shall be unlawful for any student or group of students to operate and practise as a freelance Journalist or as Writers Club, or Media Organization without first complying with the provisions in Section 17(a) of this Handbook.
- e. Every Campus Media Organization or Writers Club registered with the Student Affairs Office shall establish an Editorial Board and the composition of the Editorial Board shall be registered with the Student Affairs Office from time to time.
- f. The Editorial Board of every Media organization or Writers Club, registered with the Student Affairs Office- may consist of at least two members, of the Media Organization or Writers Club concerned.
- g. It shall be the duty and responsibility of every freelance campus Journalist or Writers' Club or Media Organization or interest group to verify the veracity or otherwise of any news item before it is published.

h.	Six copies of any journal, magazine or write-up published by a
	campus Journalist shall be deposited with the Dean of Student
	Affairs before or at the time of release of such a journal and the
	receipt be duly acknowledged.

- i. Members of a Campus Media Organization or Writers' Club shall for the purposes of disciplinary action, be individually and collectively held responsible for any: malicious, false and libelous publication published within or outside the University Campus and concerning any staff member, students, or group in the University Community.
- j. Any freelance Journalist shall be held solely responsible for any false and libelous publication made by him or her in his/her name against and concerning any staff member, student(s), or group in the University Community.
- k. The media through which the false/libelous publication was made shall also be punished.
- 1. No Press Organization shall direct a libelous or injurious article to any staff member, student(s), or group(s), in the University Community.
- m. Violation of any of these regulations shall lead to the proscription of the Press Club and members concerned shall be made to face disciplinary action deemed appropriate.

22. REGULATIONS GUIDING RELIGIOUS ACTIVITIES ON THE CAMPUS

- a. Students are free to belong to religious organizations of their choice in accordance with Sections 38 (i) and 40 of the Constitution of Federal Republic of Nigeria 1999 as amended which guarantees right to freedom of religion.
- b. No religious sermon/witnessing sermon should be undertaken in places not authorized for that purpose. For example, no religious, witnessing sermon or preaching should be conducted in the cafeteria, canteen, eatery, hostels, lecture rooms, buses, car parks or such other places.
- c. Within the room, room to room preaching/witnessing is not allowed in the hostels.
- d. i. Religious organizations are free to use University facilities after prior permission has been obtained.
 - ii. Lecture Theatres, Classrooms and laboratories etc. are primarily designed to take care of academic activities.

Where such venues are to be used for religious meetings, religious organizations must ensure that they obtain written permission from the relevant Faculty Deans, through the Student Affairs Office, before using such venues.

- iii. In any case, no religious meetings should hold in lecture theatres and classrooms two weeks before any University Examination.
- iv. For the use of University facilities, applications must be forwarded to the appropriate organ of the University for this purpose. Interested students should liaise with the Student Affairs Office.
- e. Religious organizations are forbidden to use a public address system on the campus except in authorized worship centres and periods, such as Sunday Service and Friday Jumat Service.
- f. Students' organizations or individual(s) are not allowed to paste or display religious or any type of banners, posters, literature, slickers, etc. anywhere in the campus, except with written permission of the Dean of Student Affairs.
- g. Violation of any of the above rules shall attract severe penalty, The Executive members, member or individual of such clubs/organization or individual shall be made to face disciplinary action.
- h. In all cases, the University would have precedence in the use of all its facilities.
- 23. STUDENTS DEMONSTRATION, PROTEST, LECTURE BOYCOTT, ETC.

The University recognizes the crucial importance of maintaining open communication and dialogue in the process of identifying and resolving problems, which may arise from the dynamic of life in the University. Equally important, however, is the legitimate rights of any member of the community to dissent, to disagree, to hold different opinion, or to think differently from others. This is an integral aspect of University education and academic freedom. However, the University maintains that the following regulations be satisfied:

i.

48 hours about the place, nature, methods, date and time of the commencement of the action before embarking on any demonstration, boycott of lectures, etc.

- ii. Students shall not use University property for any form of demonstration.
- iii. When a demonstration takes place on the Campus, the University reserves the right to use legitimate means to protect life and property on the Campus.
- iv. Before students demonstrate outside the campus, they must obtain Police clearance and security on their own, like any other citizens, before such demonstration and that such students shall be responsible for their own action.
- v. Students' organization must give an advance notice of at least two weeks in anticipation of a lecture free day in commemoration of any students' yearly celebrations. The University reserves the right to approve or disapprove such application.
- vi. No form of violent protests will be condoned by the University and any student found to have contravened this provision, shall be made to appear before the Students' Disciplinary Committee.

24. ANTI-SOCIAL ACTIVITY AND ATTENDANT PENALTIES

a. **Possession of Dangerous Weapons:**

Possession of dangerous weapons like guns, knives, daggers, swords, grenades, acid, etc. in the hostel or around the University premises is forbidden. Any student caught in possession of any of these weapons shall be expelled from the University.

b. Secret Societies:

- Secret societies, severally known as the Family, Mafia, Buccaneer, Pirates, Eiye, Black Axe, Black Bra, Vikins, Jezebel, or by any other names were Proscribed by the University in 1978, and later by the Federal Government in 1979. They remain firmly proscribed.
- ii. It is to be noted that the word "Secret Society" shall include

any association of two or more persons whose aims and objectives are not publicly or officially disclosed, published, registered or otherwise made known to the University Authorities; but whose activities or manifest secrecy, mysticism, pervasion, coercion, violence, fraud, immorality, drunkenness, lawlessness and related anti-social activities or behaviour.

iii. Any student found identifying with or belonging to, operating or canvassing for membership of or partaking or participating or joining and/or in other manner associating with any secret society and unregistered association within or outside the University of llorin shall be liable to a penalty of expulsion from the University.

> The generality of students are peace-loving, well-behaved, and purposeful in their efforts to achieve the objective of their studentship. The entire community should therefore note that the University, through the ambience of its regulations, **shall** deal with any discovered case(s) of misconduct and anti-social behaviour while cases of criminality would be handed over to the Police. While we shall all continue to enjoy the required atmosphere for progress, the University will spare no effort in bringing miscreants to book.

c. Public Disturbance within the Campus

- i. No student shall engage in any of these noisy and disturbing activities such as playing of drums, trumpeting, **and** playing musical instruments around administrative and academic environment except in the department of the Performing Arts.
- ii. No student shall be involved in any form of reckless driving alone or in convoy.
- iii. The violation of these rules shall constitute misconduct liable to

disciplinary action.

25. DRESS CODE

All students are hereby reminded that there is a DRESS CODE put in place by the University which must be observed at all times.

The University is determined to continue to impact positively on its students not only intellectually but also morally in pursuit of its avowed commitment to the development of **TOTAL MAN**. To this end, it will award its degrees to only deserving students who have been found worthy not only in learning but also in character. Students are therefore strongly advised to exhibit good behavior and dress decently at all times.

A. MALE STUDENTS SHOULD NOTE THAT:

- 1. the hair should be neat and well combed at all time;
- 2. the hair should not be coloured (except it is natural colour);
- 3. the hair should be well kept and groomed always;
- 4. the haircuts should not carry inscriptions;
- 5. curled hair is not acceptable;
- 6. artificial dread locks, plaiting, weaving or braiding of hair are not acceptable; and
- 7. beards must be well kept.

B. FEMALE STUDENTS SHOULD NOTE THAT:

- 1. weaving, plaiting, braiding, fixing and wigs are acceptable;
- 2. hair extensions with colours such as Blue, Green, White, Yellow, Red, Pink and Purple or a combination of any of these colours are not acceptable;
- 3. hair must be neatly packed and weaved;
- 4. the hairstyle should not carry inscriptions;
- 5. all wears must be below the knee level;
- 6. pencil trousers are allowed but must be complemented with tops that cover the butt line; and
- 7. all traditional and corporate wears that do not reveal sensitive parts of the body are acceptable.

The mode of dressing of a student speaks volumes about him or her. In other words, one's appearance influences people's perception of one's person. Students should, therefore, always dress responsibly to command respect. All students must refrain from wearing INDECENT CLOTHINGS, if they must be accorded respect and protect their dignity. EVERY STUDENT MUST HANG STUDENT I.D. CARD ON HIS/HER NECK.

C. UNACCEPTABLE WEARS

You are hereby required to note that the following constitute inappropriate mode of dressing that will not be tolerated in the University environment (including Lecture Halls, Library, Laboratories, Examination Venues, Seminar Rooms, Faculties and Administrative building as well as in University vehicles):

- 1. Dress that exposes any sensitive parts of the body e.g. cleavage, chest, back, navel, thigh and armpit (clothes that reveal the armpits when hands are raised e.g. sleeveless/half sleeves);
- 2. Tight fitting wears;
- 3. Transparent/see Through Wears;
- 4. Tattered Jeans/Ripped Jeans;
- 5. T-shirts with obscene inscriptions, depicting immorality, hooliganism, cultism, etc.;
- 6. Indelible markings and body tattoos by male students;
- 7. Leggings/Jeggings trousers with short top;
- 8. Skimpy dresses e.g. Spaghetti, Camisole only, body hugs, topless blouse and shorts;
- 9. Knickers;
- 10. Bathroom slippers not acceptable within the administrative and academic areas;
- 11. Heavy make-ups;
- 12. Sagging trousers;
- 13. Wearing of earrings by male students;
- 14. Rumpled and dirty clothes;
- 15. Skin/ear piercing by male students;
- 16. Dread, Galax, Fadeout and Rough Coil Haircuts, Unkempt Appearance; and
- 17. Hair plaiting or weaving by male students.

A collection of unacceptable/acceptable wears can be seen in APPENDIX C.

Some Faculties and Departments have prescribed Dress Codes for their students. Students in such Faculties or Departments are expected to

comply with such Codes.

D. Penalty

Violation of the Dress Code as prescribed by the University is a serious act of misconduct which shall attract stiff penalty. In addition to paying for snap shots and a fine of Two thousand Naira (N2,000.00) only, Violator(s) shall be given a strong warning and/or may be made to appear before the Students' Disciplinary Committee.

26. LINE OF COMMUNICATION FOR REPORTING CASES OF SEXUAL ASSAULT

The following channels of communication can be utilized by any student who is sexually harassed:

- i. Direct to the Vice-Chancellor;
- ii. Dress Code Committee, or
- iii. A trusted confidant.

27. USE OF THE UNIVERSITY STUDENT UNION BUILDING In order to forestall unwholesome use of the Student Union Building (SUB), the underlisted conduct in the usage of the SUB must be complied with:

- i. There should be no smoking in the building or its premises.
- ii. Gambling in whatever form is prohibited on our campuses including Student Union Building, Common rooms, and within Halls of Residence.
- iii. Students are not permitted to turn the SUB or offices to a place of abode,
- iv. Violation of these rules constitutes a misconduct liable to disciplinary action. The SUB and the Common Rooms are supposed to be relaxation centres for all STUDENTS.

28. STUDENTS' GUIDANCE AND COUNSELLING

SERVICES

In order to prevent unnecessary rise in the rate of anti-social activities among students and to encourage positive thinking and actions that would promote the attainment of academic pursuit and total well-being of the students, the University has made provisions for students to receive proper guidance and counselling from professional Counsellors. These Counsellors are housed in the University Counselling and Human Development Centre and the Annex offices located on the Main Campus, Mini Campus and the School of Preliminary Studies. Counsellors are also assigned to each Faculty in the University. Students are therefore encouraged to consult them as frequently possible for guidance/counselling on matters affecting their personal, academic and socio-personal life.

29. RECREATIONAL CENTRES ON CAMPUS OR IN TOWN

30. CONCLUSION

as

If any form of misconduct is not captured by this Students' Information and Regulations Handbook, the Students' Disciplinary Committee may exercise its discretion to apportion appropriate sanctions taking into consideration the circumstances of each incidence.

Violations of any of the University Rules and Regulations by any student(s), member(s) of the Students' Union Executive Committee or any other organizations/clubs or individual(s), may lead to imposition of fine, restitution, reprimand/warning, suspension/rustication or expulsion of any or all offending officials, and/or individual(s) concerned from the University, in addition to other disciplinary measures deemed appropriate.
