ABOUT THE CONFERENCE

Fragile contexts, characterised by weak institutions, insecurity, chronic poverty, and the abrogation of the agency of the local, that is, groups and individuals directly impacted by fragility, represent one of the most troubling and consequential challenges of our time. Across sub-Saharan Africa, the Sahel, and Nigeria in particular, the connexion of conflict, climate change, resource competition, weak states and governance failure has produced contexts wherein the human security and development needs of the most vulnerable communities and directly affected are consistently subordinated to the priorities of distant institutions and powerful external actors.

This International Conference converges, for the first time on a single platform, the twin disciplinary traditions of Peace and Strategic Studies and Agricultural Extension and Rural Development to reflect and inflect on a shared and urgent conviction: that sustainable peace and human security in fragile contexts cannot be designed, delivered, or sustained from the outside. They must be organic and even when hybrid, rooted in, owned by, and accountable to the agency of the local communities they are meant to serve.

This is why this conference appreciates contributions from academics, researchers, postgraduate students, policy practitioners, development workers, civil society organisations, security professionals, traditional leaders, and community practitioners across all relevant disciplines. Interdisciplinary submissions that cut across two or more thematic clusters are strongly encouraged and will be given special consideration by the review committee.

THEMATIC CLUSTERS AND SUB-THEMES

Abstracts and proposals are invited under the following eight thematic clusters. Each cluster is open to empirical, theoretical, policy-oriented, and practitioner-based submissions:

CLUSTER A: PEACE, SECURITY, AND CONFLICT MANAGEMENT

For scholars and practitioners in Peace Studies, Conflict Resolution, Security Studies, Strategic Studies, and International Relations

This cluster examines the structural, institutional, and community-level dimensions of conflict prevention, peacebuilding, and human security in fragile contexts. It foregrounds local agency not as a peripheral concern but as the central variable determining whether security interventions produce lasting peace or merely displace violence.

CLUSTER B: AGRICULTURE, RURAL DEVELOPMENT, AND FOOD SYSTEMS

For scholars and practitioners in Agricultural Extension, Rural Development, Food Systems, Agronomy, Livestock Science, and related fields

This cluster addresses the foundational role of agriculture and rural livelihoods in sustaining human security and community resilience in fragile contexts. It recognises that food production, land governance, and rural economic systems are simultaneously drivers of conflict and foundations of peace — and that local agricultural agency is among the most powerful and most neglected instruments of sustainable development.

Sub-themes include:

This cluster interrogates the political and institutional architecture of fragile contexts — examining how governance systems enable or obstruct local agency, and what legislative, institutional, and policy reforms are necessary to place communities at the centre of their own security and development.

CLUSTER D: NATURAL RESOURCES, ENVIRONMENT, AND EXTRACTIVE INDUSTRIES

For scholars and practitioners in Environmental Studies, Natural Resource Management, Geography, Development Economics, and Earth Sciences

This cluster addresses the complex and often deeply contested relationship between natural resource governance and human security in fragile contexts — with particular attention to the extractive industries, land rights, climate vulnerability, and the environmental justice dimensions of development in resource-rich but conflict-affected communities.

CLUSTER E: SOCIAL DEVELOPMENT, HEALTH, AND EDUCATION

For scholars and practitioners in Sociology, Public Health, Education, Social Work, Psychology, and Community Development

This cluster examines the social foundations of local agency — exploring how health systems, educational institutions, social protection frameworks, and community support networks either

sustain or erode the capacity of individuals and communities to determine their own futures in fragile contexts.

CLUSTER F: DIGITAL TECHNOLOGY, MEDIA, AND INFORMATION

For scholars and practitioners in Communications, Digital Governance, Media Studies, Information Technology, and Cybersecurity

This cluster examines the transformative — and sometimes destructive — role of digital technology and information ecosystems in fragile contexts, interrogating how digital tools can either empower local communities or expose them to new forms of harm, manipulation, and exclusion.

CLUSTER G: ECONOMICS, FINANCE, AND SUSTAINABLE LIVELIHOODS

For scholars and practitioners in Economics, Development Finance, Business Administration, and Entrepreneurship

This cluster examines the economic foundations and financial architectures of local agency in fragile contexts — exploring how access to finance, market participation, entrepreneurial innovation, and economic governance either enable or constrain the capacity of communities to build sustainable livelihoods under conditions of insecurity.

CLUSTER H: HUMANITARIANISM, DEVELOPMENT, AND INTERNATIONAL COOPERATION

For scholars, practitioners, and policymakers in Humanitarian Studies, Development Cooperation, International Law, and Global Governance

This cluster addresses the international architecture of humanitarian and development assistance in fragile contexts — critically examining the gap between global frameworks and local realities, and advocating for a genuine localisation of the humanitarian-development-peace agenda that places community agency at its irreducible centre.

2. Aid Architecture and Local Ownership: Reforming International Development Assistance for Fragile Contexts

Who Submits an Abstract

Abstracts are welcome from academics, researchers, postgraduate students, policy practitioners, development workers, civil society organisations, security professionals, traditional and religious leaders, and community practitioners from Nigeria, Africa, and the international scholarly and practitioner community.

Types of Submissions

Submissions may take one of three forms. Individual paper presentations for a single author or co-authors to present original research findings, theoretical arguments, or policy analyses in a 20-minute conference slot. Panel proposals combine three to four thematically related presentations under a connecting argument, with a designated panel discussant and a collective 90-minute session. Practitioner case study presentations offer development workers, community leaders, civil society organisations, and security professionals a structured platform to present field-based evidence, programme evaluations, or community-led innovations — without the requirement of a formal academic paper.

Interdisciplinary Submissions

Abstracts that permeate two or three thematic clusters are strongly encouraged. The conference is explicitly designed as a space where disciplinary boundaries dissolve in the service of more

integrated, locally grounded, and practically useful knowledge. Interdisciplinary submissions will receive priority consideration in the review process.

Abstract Requirements

All abstracts must be written in Times New Roman, size 12; Single spacing and can be between 250 and 500 words for case studies. Abstracts and case studies must clearly articulate the research question or central argument, the theoretical or conceptual framework, the methodology or evidence base, the principal findings or expected findings, and the contribution to the conference theme of enhancing local agency for human security and sustainable development. Abstracts must indicate the thematic cluster under which the submission is made and, where applicable, the sub-theme it addresses most directly.

Language

Abstracts and presentations must be submitted in English.
